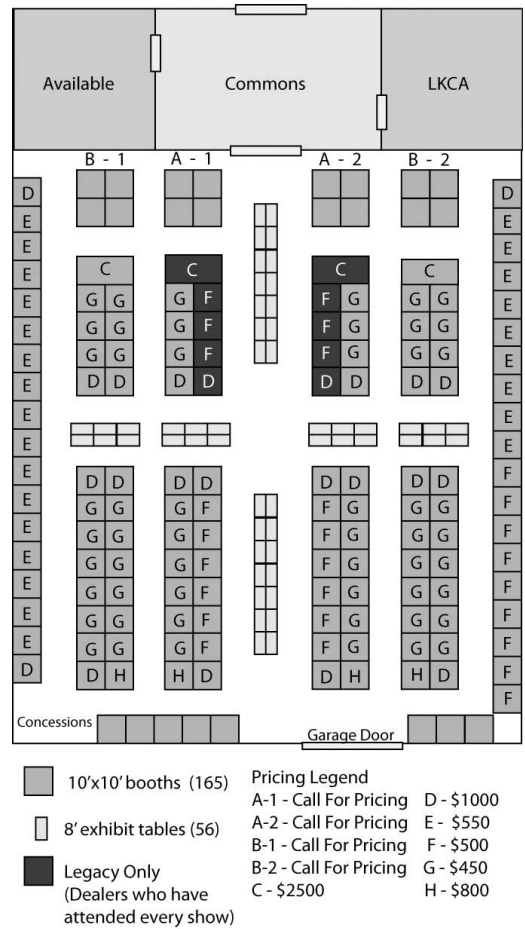

Bourse Table Application

1. Dealers who wish to retain their table position from last year must submit application for space by January 31, 2012.
2. See attached floor plan for table prices. Location will be determined based on availability. Table fee includes one eight foot table with backup, 2 cases, electrical, 2 chairs. Limited number of lamps will be available at \$10 each.
3. You are a paid, pre-registered dealer upon payment in full of your bourse fee. Dealer's names will not appear in our advertising unless full bourse fee has been paid. A check for at least \$200.00 must accompany this application. The balance must be received no later than April 1, 2012. You will not be billed. Mark your 2012 calendars for final payment deadline.
4. Bring your badge from 2010 or 2011. All badge reprints are \$20 each. No exceptions. All bourse fees must be paid in full before entry. Dealers will be admitted to the bourse area at 12 noon on Thursday, June 7, 2012. **No dealer or assistant will be permitted in the bourse area unless he/she is pre-registered and wears the official dealer badge.** Early bird badges are available for \$75 for all non-table holders. You cannot add them to your table at the show.
5. Show opens to dealers at 8:00 a.m. and to the public at 9:00 a.m. Friday, Saturday & Sunday. Show closes at 5:00 p.m. on Friday and Saturday and 3:00 p.m. on Sunday.
6. Security will end at 6:00 p.m. on Sunday, June 10, 2012. Security room will be available on Wed. June 6th at 12 noon and close Thursday, June 7th at 12 noon with no security storage fee for 2012.
7. Total refund of all payments will be made if cancellation is made on or before April 1, 2012. Cancellation after April 1, 2012 will have \$100.00 deducted as a cancellation fee. No refunds will be made on cancellations after May 7, 2012.
8. The bourse table assigned you may not be resold, rented, loaned, leased or shared by another dealer, individual or company without written consent of the bourse chairman.
9. **Checks payable to LFK Tradeshows.**
10. Dealers are expected to have booths staffed, with inventory on display until the close of business on Sunday. Dealers whose booths are not open (staffed, with inventory on display) at the close of business on Sunday will not be guaranteed the same booth location at the next show, and they will be moved to the bottom of the waiting list for upgraded locations.
11. No dealer may knowingly exhibit or offer for sale any illegal coins, counterfeits, forgeries, unmarked copies or other spurious merchandise. The penalty for such action shall be immediate ejection of the dealer from the bourse and the possible suspension and/or subsequent expulsion from future Memphis conventions.
12. Insurance against loss of material is the responsibility of the dealer.
13. Show management reserves the right to revise show dates and/or hours.
14. Dealers are responsible for compliance with all federal law, state law, local ordinances and state regulations including, but not limited to the Tennessee sales tax laws. We encourage all dealers to consult their legal and/or tax advisor as to their responsibility to do business at the Cook Convention Center.
